**Attention:** Paralegal Candidates Entering the 2022-23 Licensing Process

**CC:** College Program Heads/Coordinators of Accredited Paralegal Programs

**Re:** Application for the 2022-23 Paralegal Licensing Process

**Application Deadline: December 1, 2021, by 5 p.m.**

This letter describes the application process and procedures for admission to the Law Society of Ontario's 2022-23 paralegal licensing process. Your college/institution has kindly agreed to distribute this information to all students preparing to apply to the paralegal licensing process.

We ask that schools and applicants review the exam dates posted online (see below).

All candidates in the licensing process must complete the following requirements in order to obtain a P1 paralegal licence in Ontario:

- Successful completion of the paralegal licensing examination. For your reference, [licensing examination dates and deadlines](#) are posted, as they become available. We ask that applicants and schools review the examination dates when planning graduation dates so that conflicts are avoided where possible, and to allow for additional travel time between graduation ceremonies and examination sittings.
- Be of Good Character;
- Submission of a final official transcript sent directly from the issuing institution to the Licensing and Accreditation Department before the applicable registration deadline for the selected examination date. Note that the Licensing and Accreditation Department is now accepting final transcripts from schools through the Digital/MYCREDS secure platform, in addition to the previous methods of receiving transcripts (electronically with password protected files and in paper format). You must request this document be sent by your college in advance of the deadline; and
- Payment of all fees and filing of all forms/documents as required by the Law Society.

The Paralegal Licensing Process application consists of two parts:

**Part I** consists of an online application.

**Part II** includes submitting a certified paper version of the application along with the required fees and supporting documentation to the Law Society. The application and supporting documents are to be certified by a guarantor/referee and more information on this requirement is available on the [Completing the Paralegal Licensing Process Application](#) webpage.

You **MUST** complete and submit both parts of the application process to be admitted to the paralegal licensing process. Applicants who do not complete both parts of the application will be removed from the process and will not be billed or scheduled for the licensing examination. Both parts may be completed beginning in October 2021, once the online application is live.

To complete Part I of the application process:

1. In early October, visit the [Application for Admission](#) page.
2. Select "**Apply Now**" in order to access the online application for 2022-23.
3. Ensure you review the [Completing the Paralegal Licensing Process Application](#) page for more information.
4. We are encouraging candidates to apply as soon as possible now that the application is available. Applying as soon as possible allows candidates adequate time to make arrangements to have their documents certified according to the application requirements outlined on the [Completing the Paralegal Licensing Process Application](#) page. The online application itself takes about 20-30 minutes to complete.

## **Certifying the Application and Supporting Application Documents**

Once candidates complete Part 1 of the application process online, candidates are expected to download their PDF application file from their Law Society online account and provide it to a guarantor/referee in order to proceed to Part 2 of the application process. The documents do not need to be commissioned by a commissioner or notary public but do need to be certified by a guarantor or referee as outlined in the [Completing the Paralegal Licensing Process Application](#) section of the website.

### **Dates to Remember:**

Applicants have until **December 1, 2021, 5:00 p.m. EST** to **complete and submit** the application/fee before incurring a late filing fee. If you intend to write the Summer 2022, Fall 2022 or Winter 2023 licensing examination you may begin applying in October 2021.

### **Candidate Licensing Term:**

You will have a three-year licensing term to complete the requirements of the licensing process. As a new applicant to the process, your licensing term will begin on June 1, 2022 and end on May 30, 2025 (unless you begin the licensing process in an earlier licensing cycle).

Candidates who have fulfilled all necessary prerequisites, including completion of an accredited paralegal education program and have submitted all other supporting documents to the Law Society may be eligible to be registered for the Winter 2022 Licensing Examination. The [Completing the Paralegal Licensing Process Application](#) section on the website has more information on selecting a sitting in an earlier licensing cycle. It is suggested that candidates who intend to write their examination in Winter 2023 wait to apply in the next intake period which occurs next October 2022.

### **Additional Information:**

Information on the licensing examination, rules, policies, deadlines and dates to remember are also posted on the paralegal licensing process section of the Law Society website. You are strongly encouraged to review the information to ensure you are aware of all the requirements and deadlines.
